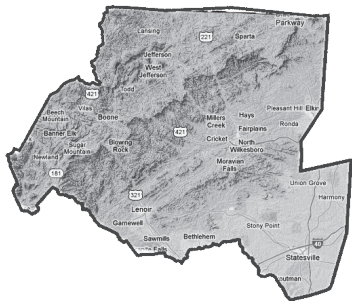
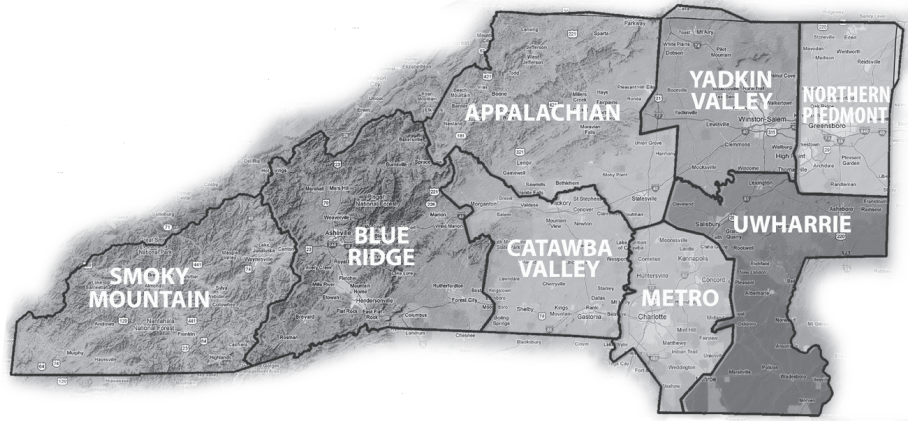


II. DISTRICT ORGANIZATION

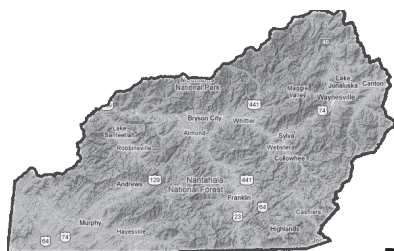

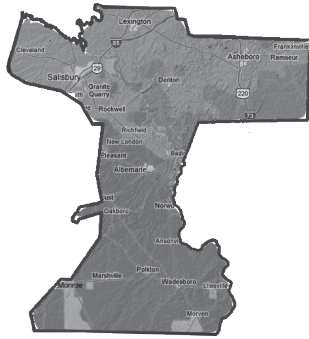
